The schedule for the admission is as follows:

Last Date for Fee Submission (Regular Stage)	25 <sup>th</sup> July 2026
Checking of Statement of Entry (If the student does not check and sign the statement of entry, the School will not be responsible for any mistake or wrong entry and no claim from the student or parent will be accepted)	06 <sup>th</sup> and 07 <sup>th</sup> July 2026
Retake/Late Stage-1 Entries (Penalty fee Rs. 25449/- per subject plus subject fee)	31 <sup>st</sup> August 2026

Please Note that after 25<sup>th</sup> July 2026 no regular admission will be accepted.

- Passport for foreign nationals and CNIC for local nationals is a MUST in addition to their School ID card and Statement of Entry on the exam venue.
- All Candidates are required to submit copy of their CNIC or Smart Card along with admission fee by 25<sup>th</sup> July 2026.
- Penalty fees for late submissions (entry for new subjects or change of syllabus after final entry closing dates) are charged by Cambridge per candidate per subject in addition to the normal subject fee.
- Before exam, students can receive their original statement of entry after getting clearance from the School Accounts Office. **No statement of entry will be issued without clearance.**
- The admission of any student will not be sent as regular candidate from the School without clearing the mock examinations.
