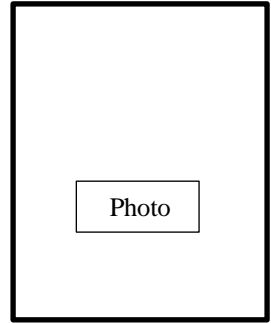

2. School reserves the right to accept or reject any admission or withdraw after admission which shall not be challenged in any Court of Law and Forum.
3. I agree:
  - i. to pay the fees in advance timely, as laid down in the School rules, and to give one term's notice of withdrawal or to pay one term's fee in lieu thereof.
  - ii. to pay the scale of fees fixed from time to time by the Competent Authority/Board of Governors which shall not be challenged in any Court of Law and Forum.
4. I understand that:
  - i. the admission offer for H1(As-Level) is provisional and will be continued after the declaration of O Level results (8 subjects pass).
  - ii. in case of failure in any subject/s of O-Level (8 subject/s) or As Level, my son/daughter will appear in all the failure subject/s in CAIE May/June exams in the following year.
  - iii. if he/she fails in any one of the subjects in CAIE May/June exams, or secures low percentage/merit, then his/her admission will be withdrawn from the School.
  - iv. the admission offer for I1(F. Sc) is provisional and will be continued after the declaration of Matriculation results (Pass in all subjects).
  - v. in case of failure in any subject/s of BISE Matriculation 1<sup>st</sup> Annual examinations or due to low merit, this admission offer may be cancelled/withdrawn by the School.
  - vi. students admitted as boarders will remain as boarders for the school year in which they are admitted and not be re-designated as day pupils. The boarding fee will be applicable for the full year.
  - vii. all places are subject to continued commitment and progress in all areas of activity, (i.e Discipline, Academics, Sports, Non-sport activities, and Community Service etc.)
  - viii. a student's entry to Public Exams as a regular or private candidate will be decided by the School on the basis of attendance, academic performance and the Sadiq Standards.

## UNDERTAKING

- iii) If my Son/Daughter/Ward gets involved in any unlawful activity, violates School/Boarding House rules, indulges in scuffling, intimidates his/her juniors and keeps unauthorized/objectionable material (e.g. drugs etc.) in his/ her possession, the School administration may take any disciplinary action against him/her and I will have **no objection** in this regard.
- iv) His/her admission is probationary and he/she may be withdrawn from the School in case of violation of any one of the above (i), (ii) or (iii).
- v) Students admitted as Boarders will remain as boarders for the School year in which they were admitted and not be re-designated as Day Pupils.
- vi) Students whose parents are settled abroad/ frequently travel abroad will only be considered for admission if a legal representative who is a permanent resident in Pakistan is nominated, with appropriate verified documentation submitted.
- vii) Day pupils will not be admitted unless they reside with at least one parent or legal guardian and remain residing with a parent/ legal guardian throughout their enrolment.
- viii) If he/she does not meet any of the criteria or does not fulfil any of the Sadiq policies (which may change time to time at the School's discretion), then his/her admission to BISE/CAIE will not be entered as a regular candidate.

## Code Of Conduct

- a. All parties to all matters relating to Sadiq Public School, i.e. students, parents/representatives, teachers and any other must treat the School and each other with respect.
- b. Students' personal information is confidential to the School, the student, and the students' parents/representatives. It is therefore inappropriate for third-parties to make representations to the School on behalf of students and their parents.
- c. Information relating to students will be held in a personal file, which will be kept secure by the School.
- d. All documents submitted to the School by students or their parents/ representatives must be authentic, i.e. not falsified or altered in any way, failing which the admission application will be rejected. If at any time after admission, documents submitted as part of an admission application are found to have been falsified or altered in any way, the student's admission will be cancelled and the student will be withdrawn from the School.
- e. Students and their parents/ representatives are expected to be honest, courteous, and respectful in all dealings with the School and its staff.
- f. Students and their parents/ representatives agree to behave according to the rules, regulations, and procedures (including the Accounts Policy) in letter and spirit, failing which the admission may be terminated.
- g. Parents/ representatives accept that the School will take all reasonable measures to ensure students' safety, however the School will not be responsible for any accidents and physical harm or injury caused by student or parent negligence.
- h. Parents and students must not engage in negative, critical, or humiliating social media activity relating to the School or any members of the School community including staff and students, failing which the student's admission will be cancelled and the student will be withdrawn from the School.
- i. Students and their parents/representatives must behave within the letter and the spirit of the laws of Pakistan.
- j. Students and their parents/representatives who have disputes with the School are expected to address these disputes in a private, confidential and timely manner, taken up in the desired manner with concerned office holders at Sadiq Public School. Both students and parents, in any case, are not desired to engage in public disputes with the School, involving any form of media (both electronic and/or print media such as newspapers and television channels) or internet-based forums, channels or social media networks. Any violation in this regard result in the student's admission being cancelled and the student will be withdrawn from the School.
- k. Any breach of any aspect of this Code of Conduct (or part thereof) by students or their parents, guardians or representatives is liable to result in the termination of Admission/withdrawal from the School.
